

STAND YOUR GROUND! NOW PERMITLESS CARRY! OH MY!!

Statutes 776.013 and HB543

The state of Florida adopted a Stand Your Ground Law in 2005. As of July 1, 2023, the state of Florida has adopted a permit-less carry law. Now before people get their dander up assuming I am against owning a gun, let me be clear. I am a gun owner. But also let me be clear. I am a trained gun owner. I have a conceal and carry permit which means I've taken a firearms class. I go to the range. I know enough about guns to take my personal firearm apart and clean it myself. I don't leave firearms unsecured throughout my home. I am a RESPONSIBLE gun owner. I have also NEVER shot a person or shot at a person. My firearm is strictly for protection. I value life and would never want to shoot someone if my life or a loved ones' life wasn't in imminent danger.

Regarding the Stand your Ground law: This law allows people who feel they are in danger or their property is in danger the choice of not retreating but shooting instead. This law allows you to legally shoot someone and possibly take a life rather than try to de-escalate the situation or call law enforcement. My question is "how has this law affected people of color"? When someone uses this defense, how is the law applied and are the results equitable? Many people will say "of course". But if you are African American or a person of color you know the answer is a resounding NO. For this article I wanted to find out if what I and my African American friends believe is true or not. So, I went looking for facts.

Let's start with the most recent case to hit the news. Ajike Owens, a Black woman and mother of four children, was shot through a closed and locked door where she stood with her young son by Susan Lorincz, a White woman. Neighbors have reported that Owens children have repeatedly been subjected to racial slurs, being yelled at by Lorincz and have had items thrown at them while playing with other children over the past two years. It has also been shown that Lorincz researched the Stand Your Ground Law on at least two recent occasions.

On this day Lorincz has been accused of throwing a roller skate at Owens 10-year-old son hitting him. When the boy and his 12-year-old brother tried to speak to Lorincz, Lorincz swung at them with an umbrella and told them to "go get your mother". When the boys told their mother, Ms. Owens went over to speak with Lorincz. She knocked multiple times and shouted for Lorincz to come outside. Owens was visible on Lorincz's doorbell cameras so she could see Owens was unarmed, yet Lorincz fired through the closed door striking Owens who later died at a local hospital. Lorincz then called 911 stating that she feared for her life, was being threatened and shot her neighbor. Was Lorincz arrested? Not immediately. She claimed "stand your ground" and was allowed to remain free for at least two days. Lorincz has since been charged with one count of manslaughter and one count of assault. Despite researching SYG in the days before the shooting, despite hitting one of the Owens children with a skate and other objects, despite calling neighborhood children racist names, the local authorities have not charged Lorincz with murder or a hate crime. Lorincz was granted bail by the judge overseeing the case, which she has not been able to raise as of this writing.

Would she have been allowed to remain free for days if she had been Black and Owens White? Would Owens have been granted bail if she was the shooter? That's a good question. There have been definite disparities in the application of this law, especially when the shooter and the victim are different races. In this case, it is clear that Lorincz was repeatedly the aggressor, even assaulting the Owens children as well as other neighborhood children.

In the latest comprehensive study I could find, it was shown that despite the perception, Stand Your Ground (SYG) laws do not deter crimes. Rather, they have been shown to increase firearm homicides in states with SYG laws. In Florida, the law was associated with a 45% increase in firearm homicide rates.

A study by the Urban Institute (2013) found that in cases where both the shooter and the victim are White, 11% of the cases were deemed justifiable. When both parties were Black, the percentage of justifiable shootings dropped to 8%. However, the most telling of racial bias occurred when the shooter and victim were of a different race. If the shooter was Black and the victim White, the shooting was ruled justifiable only 3% of the time. Yet, if roles were reversed and the shooter was White and the victim Black, the rate of being ruled justifiable rose to 34%. This was after taking into account circumstances of the shooting such as if the victim was involved in committing a crime against the shooter or the shooters' property. Three (3%) percent vs thirty-four (34%)? Wow! Other cases that come to mind where the SYG law was applied was the killing of Trayvon Martin. Martin was a 17-year-old returning from the convenience store after buying candy when he was accosted by George Zimmerman because as Zimmerman told the 911 operator he

(Martin) looks suspicious". Despite Zimmerman being told to not confront Martin, he did. When Martin defended himself, Zimmerman shot Martin killing him. Zimmerman was later acquitted with the SYG defense, despite being the initial aggressor.

There have been numerous other cases where Blacks have been the victim yet their White aggressor was able to successfully use the SYG defense despite initiating the conflict. A few have resulted in jail time for the aggressor such as the Ahmad Aubery case in GA and the Jordan Davis case in Jacksonville. We also have cases not yet adjudicated where the SYG defense is being utilized such as the Ralph Yarl case in Kansas City. This young man went to the wrong house to pick up his younger brothers and was met with a bullet to the head. Miraculously Yarl survived, but he will be scarred physically and emotionally for the rest of his life. Question: Will Yarl's shooter be one of the 34% who get away with shooting a person of color, in this case a Black teen honor roll student, primarily because the shooter is White and the victim is Black? Please, consider these statistics when pushing for laws that unwittingly or unfortunately and unfairly target people of color.

Now my new concern is the concealed carry law that took effect July 3rd. What happens when a Black man has a concealed weapon and someone notices the tell-tale bulge. Will HE be considered a threat despite it being legal to conceal and carry without a permit? Will my son or my husband, minding their own business, be considered a threat, treated differently than their non-melanated neighbors? Do I need to worry about my son or husband being shot by someone who then uses the Stand Your Ground law to cover their bigotry of a person of color exercising the same right to bear arms as a non-person of color?

As women of faith, as women of the ELCA, I ask that everyone think about this. Please think about the effect of these laws and the consequences on our brothers and sisters of color. This is me. I am affected by these laws.



Archives Corner

It was suggested that I submit a column to *Tapestry* at the Synod Assembly this year. I debated upon a topic, and decided to do the first one on an issue we all face sooner or later!

Most of us have boxes of photographs in our collections that we hate to throw out. Yes, a lot of us are now digitized, but our parents and some of us born before digital cameras have many print photos. Who are these people? Where were we when we took this photo?

If you still have parents living who know some of the strangers in your picture box, don't waste any time-in asking for their help in identifying the people you don't know. A friend inherited a box of photos from her aunt and tried to get her father's assistance in identifying the people. But he wasn't interested in helping, so it just was a box of old photos. Your photos may get a relative to tell you a story you hadn't previously known. You might learn family history previously unrevealed!

Common lore has it that you want to write on the back of photos with pencil so it doesn't bleed through, but experi-

ence has shown me that pencil doesn't always work on photo paper. So, if you use ink, make sure any labels are written on the edges of the back of the photo, so if they do bleed through, they are not across someone's face! You can also use labels if you are making an album or scrapbook.

If you choose to put these photos in an album or scrapbook, use photo corners if you can find them. Hobby and office supply stores usually still carry them, or you can order acid free corners online. Do not use the "magnetic, plastic sheets" they discolor your photos after a time.

If there is no one of the previous generation to identify photos and you know no one in them or have no clue where the picture was taken...you can discard them with no regrets. Though, maybe an antique store might want them! I have seen old photos in antique stores and wondered who didn't want them anymore!

FLORIDA-BAHAMAS SYNOD ASSEMBLY 2023

Synod held the 23rd annual Assembly at the Caribe Royale Resort Synod in numerous ways were in Orlando. The opening service prepared us well for our theme of renewal.

The voting members were anticipating their responsibility to elect a bishop for a six year term. Once the first ballot was collected, business proceeded. When the results of the first ballot were read, the applause rocked the room. Bishop Pedro Suarez had been re-elected on the first ballot. The subsequent business proceeded just as smoothly throughout the Assembly.

The Synod introduced a new program at this Assembly. Vision 2 Action is a grant funding mission that was developed in response to the results of a year-long listening process. The thou-
