# Report on First Coast Conference Spring Gathering 2025

The First Coast Conference Spring Gathering was held at Crossroads Lutheran Church, Fleming Island, on May 17, 2025. The theme was "There's Grace for That" expressing thanks for "the riches of God's grace that He lavished on us" (Ephesians 1:7-8). We were welcomed by Shirley Norton, Crossroads Congregational Unit President. Pastor Rebecca Craig of Crossroads Lutheran provided the opening prayer. Rachel Mumford, First Coast Conference President, read the WELCA mission statement and thanked everyone for being in attendance.



Pastor Craig, not only a pastor but also an author and an artist, spoke to the audience concerning abuse and the need to speak out and not be silent. She discussed her books, *Once Upon A Nightmare* and *Through Her Eyes: Biblical Women Speak*, the first discussing narcissistic abuse and her personal experience, and the second looking at the hardships and challenges women in Biblical times endured. The second speaker was Carmen Queen of Mercy Support Services. Mercy Support Services is a Christ-Centered non-profit whose focus is on the prevention of homelessness. They provide



numerous services such as financial counseling, job finding, secure childcare, and similar resources to help their clients learn necessary skills to succeed in life. Before the break, the conference and the Crossroads CU recognized and thanked the speakers.

We broke for lunch, provided by the hosting unit, and had time for fellowship before regathering for the business meeting. The business portion included the election of a new Vice President and discussion from the SWO board rep on what the SWO is and how we can help and support the Congregational Units and vice versa. It was a very educational and rewarding gathering shared by these sisters in Christ!

# 2026 Triennial Nomination for Voting Member

The 2026 Triennial Convention will be held by Zoom on Tuesday, July 14-16. If you would like to place your name on the ballot for Triennial Voting member, please complete Triennial Voting member Nomination form located on www.flwelca.com

At its October 2017 meeting, the churchwide executive board adopted the following rank order process for use in electing voting members to the Eleventh Triennial Convention (2020). It was used again at the Twelfth Triennial Convention (2023).

The Triennial Gathering will be held in Des Moines. Iowa Thursday, July 16-19.

### **Proposed Rank Order Process**

Our constitutions provide two criteria that need to be met in the election of voting members for the triennial convention:

- 1. as nearly as possible, at least 10% of the delegation shall be persons of color or whose primary language is other than English
- 2. at least one-fourth of the voting members shall be women attending the convention for the first time

The simplest way to achieve these criteria is to present a ballot with three tickets.

- Ticket A will be used to elect the number of women of color or whose primary language is other than English as set forth in the constitution;
- Ticket B will be used to elect the number of first-time voting members as set forth in the constitution; and
- Ticket C will be used to elect the remaining number of nominees needed to complete the delegation.

The election(s) on Ticket A will be conducted first and resolved before moving to Ticket B. To be elected on Ticket A, a woman must receive a majority of votes (i.e., fifty percent of the votes cast, plus one). If an election does not occur on the first ballot, the number of nominees on the second (and all succeeding ballots) is limited to twice the number of voting members needed to be elected on that particular ticket.
